The Data Controller of your personal data is liable to you for the legitimate and correct use of your personal data and may be contacted for any information or request.

Your personal data may be disclosed to third parties exclusively with the purpose of complying with legal requirements and to ensure proper administrative management.

Your personal data can be communicated in particular to the following categories of subjects:

consultants, professionals and professional firms, Banks and Credit institutions, logistic providers, shippers and transporters, relevant authorities, Institutions to whom the right to access data is permitted by law, and, in the case of late payment, to our legal counsel.

If necessary, we will inform you of the names and contact details of the data processors of your interest.

Your personal data will be collected and processed, mostly by means of IT and telematic tools, with the purpose to allow the management of contractual obligations and of accounting and administrative requirements.

The processed data may be: tax code and other personal identification codes; name, address or other personal identification elements; contact details (phone number, e-mail etc.).

- The duration of treatment is determined as follows: the personal data are stored for a period of 5 years and in any case according to the timing provided by current legislation.
- You have the right to ask the Holder of the treatment to access your personal data, to obtain their correction or the cancellation, the right to obtain treatment limitation, the right to oppose at any time to the processing of personal data.
- You have the right to withdraw the consent given to the treatment for one or more specific purposes at any time.
- You have the right to lodge a complaint with the Supervisory Authority for the protection of personal data, represented by the Privacy Authority.

To exercise these rights, you can contact the Data Controller at the contact points here indicated by submitting an informal request, also through an authorized person; your request will be appropriately answered without delay.
